IETRO LETTER CARRIER

FROM THE PRESIDENT'S DESK

The saga continues! With the Postal Service conceding that the Consolidated Casing Initiative was a disaster, here we go again with the Expedited Street/Afternoon Sortation (ESAS) Test.

Selected as test sites for the City of Dallas are Caesar Clark, Parkdale, and Pleasant Grove Stations, along with the associate offices of Carrollton MPO, Longview Northwest, and Gainesville. It was originally stated that carriers would case preferential flats and pull down the morning

of delivery; however, it appears that management throughout the district has implemented a variety of versions of the test, termed as "Grab & Go". It was stated that this test would last 30 days with there being a possibility of extending for an additional 30 days.

Please note that this is a unilateral test. NALC did NOT have any input in the decision to conduct the test or any input in the way it is being conducted. NALC is of the position that the following office functions should still be performed while on Office Time.

- Stand up talk/Scanner Minimum office time 9 minutes daily
- Withdraw parcels Minimum office time 5 minutes daily
- Vehicle Inspection Minimum office time 3 minutes daily
- Accountable Mail Minimum office time 6 minutes daily
- Personal Time 5 minutes daily
- Break 10 minutes in the AM is optional; both can be taken on street time
- It has been reported that some offices are clocking straight to

street time and performing all duties on street time with no office time being recorded. Please let us know if this is happening in any of your offices.

With this type of test comes delayed mail. If management has implemented such an initiative in your office and mail is getting delayed/curtailed, please contact the union hall to let us know the days the mail was delayed/curtailed, how much mail was delayed/ curtailed, and the reason for the delay. We all know that this is an injustice to our customers. We need full cooperation in collecting this data so that it can be reported to our national officers.

NALC was also informed at the national level of the Postal Service's intent to conduct a study of city carriers' office activities in the AM and PM to collect data to use for the establishment of new work methods and standards. The study will be conducted by a third-party contractor hired by the Postal Service. Only thirty-six (36) offices throughout the nation were selected for this one-week test which began on August 10, 2020. Richland Station in Dallas was selected as one of the thirty-six test sites. It is important during this observation that carriers at Richland conduct all the office duties of a city carrier. Failure to provide adequate data could easily affect the entire nation. We are depending on your complete compliance.

On a final note, COVID-19 is still looming. The district total of confirmed cases as of today is 179. The numbers are increasing daily. Due to the nature of the work performed by letter carriers, you are essential to the communities you serve. It is of the utmost importance that you place your safety and the safety of others first by wearing your protective equipment. As a branch, we are continuing to follow the guidelines of CDC; therefore, we are conducting our monthly branch and steward meetings via ZOOM. If you would like to be a part of the meeting, please contact the union hall with your name and email address so that we can gladly include you in the meetings. Please see the calendar on the back page for the days and times of the meetings. Until we see one another again, take care and stay safe!

ARE YOU REGISTERED TO VOTE?

Check out Vote411.org - a website sponsored by the League of Women Voters Education Fund. This is a one-stop website for all your voting needs. From this website, you can get information about upcoming elections and verify your voter registration. Be aware - if you have moved recently, your voter registration may have been deactivated, and this website will help you verify that your registration is active. You can also print out a voter registration form to mail in. You must register by October 5 in order to vote in the presidential election on November 3. If you register now, you can take advantage of early voting which begins on October 13. Check now to be sure you will be ready!

WHAT HAPPENS TO YOUR UNION MEMBERSHIP WHEN YOU RETIRE?

Retirement is something that we look forward to - leaving behind the bosses, the alarm clocks, the bad weather. But don't leave behind your union membership when you retire! Staying in the NALC is a good idea for retirees:

- Every retired member receives a free \$5,000 accidental death policy from the NALC.
- The NALC Retirement Department can help you solve problems with your retirement benefits.
- Your subscription to The Postal Record will continue.
- Retirees who remain members can vote in NALC elections and can serve as officers and convention delegates.
- The support of retirees gives NALC a voice with congress on retiree issues.
- Branch 132 has a quarterly luncheon and an annual banquet for retirees who remain members.

All of this - and for only \$1 a month! That includes national dues of \$7 a year, and Branch 132 dues of \$5 a year.

So how do you retain your NALC membership when you retire? The NALC mails all recently retired members a retirement packet that contains a Form 1189. If you don't receive that packet, call Danny Hilliard at the union hall and the branch can provide you with a Form 1189. Fill out that form, and give it to a Branch 132 officer. Make sure you have your CSA number on it, which is a number assigned to you by OPM after you retire. That officer will then forward it to the national office - and that's all you have to do! Dues will be deducted from your retirement check every month.

But wait - there's more! After 50 years of NALC membership, you will become a life member of NALC, and no more dues are required.

The NALC encourages retired carriers to maintain their membership in the NALC. The retirees help provide history and mentoring to the new carriers, and help the NALC fight for good retirement benefits, and that helps all carriers, active and retired. Retirees can also help the NALC with legislative issues without having to abide by the onerous Hatch Act restrictions that encumber active letter carriers.

So watch your mail for your retirement packet, and make sure you return the 1189 to the branch when you retire so that you can stay a member of the NALC!

HISTORY REPEATS ITSELF

The COVID-19 crisis isn't the first time the nation's postal system has risen to the occasion during a national health emergency. Postal workers also played a critical role during the 1918-19 influenza pandemic. "Letter carriers then and now were on the front lines," said Jenny Lynch, the Postal Service's historian.


The 1918-19 flu outbreak was the deadliest pandemic in modern history. An estimated 50 million people died worldwide, including approximately 650,000 in the United States. Called the "Spanish Flu" because newspapers in Spain printed uncensored coverage of the pandemic, the virus is believed to have originated at an Army training camp in Kansas before traveling with American troops to Europe in spring 1918. In crowded military camps and trenches in war-torn Europe, the virus is thought to have mutated into a deadlier form.

The first cases of the more lethal flu in the United States were reported among returned servicemen in Boston that August. Within weeks, the flu jumped to civilian populations and quickly spread to cities nationwide.

From coast to coast, local and state governments enacted social distancing measures – including closing schools, banning public gatherings and shuttering some businesses – in a desperate attempt to stop the spread of the disease. Some people were also ordered to wear cloth masks.

Through it all, the U.S. Post Office Department kept the mail moving, although not without challenges. In Washington, D.C., for example, more than 150 postal clerks and carriers fell ill during the first week of October 1918 – the deadliest month.

Washington Postmaster Merritt Chance urged high school boys to work at the Post Office – for as long as schools were closed – to keep operations continuing. A week



later, he required all clerks who interacted with the public to wear gauze masks. In other towns, especially in the West, Post Offices reduced or even suspended service. In most U.S. cities, the flu peaked between September and November 1918, then weakened in early 1919.


In a 2007 study, researchers from the Centers for Disease Control and Prevention and the University of Michigan's Center for the History of Medicine found that social distancing saved lives during the pandemic. Cities that implemented social distancing measures early, and kept them in place the longest, experienced lower overall mortality rates.

Historians like Lynch have also noted the important role that mail played in keeping people connected during the 1918-19 pandemic and other times of crisis. "The ability to connect can be, quite literally, a lifeline during times of extreme stress," she said. "Mail enables the exchange of vital supplies and information. Perhaps even more important, it can provide hope, comfort and purpose."
