## **EXECUTIVE VICE PRESIDENT'S REPORT**

When I began my career as a city letter carrier in Lewisville, Texas, back in 1975, there was no structured training program. On day one, I punched in and went directly to the street with one of the senior carriers. He drove the jeep, while I rode in the back on the wheel well, with no seat belt. When we got to the first delivery on his route, he gave me a pouch full of mail and I was off and running. With his direction, I carried most of the route. The next day, I went with another letter carrier. After a week, training with a different carrier every day, my training was complete. What I didn't learn that week, I somehow figured it out as I went along. I'm sure many of our older retirees can relate to my training experience.

Over the years, training has improved. Currently, our new City Carrier Assistants go through a very comprehensive training program that includes a "Shadow Day" where they just watch a letter carrier perform his or her street duties. They then go to the Carrier Academy for four days. This part of their training allows them an opportunity to learn the technical aspects of their duties. After that, they participate in at least three days of on-the-job training at the station. Once this training is complete, they pretty much have a good grasp of their duties as a city letter carrier.

On another subject, I would just like to say that 2020 will go down in history as a moment in time where our future was uncertain. As each month went by, we sadly realized that we were all in it for the long haul. It is almost certain that 2021 will just be more of the same, until a vaccine has been approved and distributed to the masses. I've said it before and I'll say it again: history will recognize the men and women that delivered the nation's mail during this tragic pandemic as essential and heroic. We should all be proud of that.

In closing, I would like to wish every letter carrier, active or retired, a very happy and prosperous holiday season. Lord knows, you deserve it.

#### A NEW CONTRACT HAS BEEN PROPOSED

NALC and USPS management have agreed to a tentative contract. The agreement will last 44 months, from September 20, 2019 to May 20, 2023. The agreement provides four annual general wage increases and seven cost-of-living adjustments (COLAs) for career carriers during that period. City Carrier Assistants (CCAs) will receive four annual general wage increases that are 1% higher than those awarded to the career carriers in lieu of receiving COLAs. In addition, effective November 19, 2022, a new top pay grade (Step P) will be added to the career letter carrier pay scales. Step P will pay \$444 more annually than Step O. The agreement also provides for the automatic conversion of CCAs to career status once they achieve 24 months of relative standing, which will provide full fringe benefits and peace of mind to non-career carriers. Existing protections against subcontracting and layoffs are maintained.

All Branch 132 members will have an opportunity to decide whether or not to accept the tentative agreement in an upcoming ratification vote. Watch your mailbox in January for a summary of the proposed contract and your ballot. Return the ballot by the deadline to make your voice heard! In the meantime, check out the new proposals in more detail at nalc.org.

Emergency paid sick leave can be used only one time.

All unassigned regulars that were moved to other stations that had hold-downs will be returned to their hold-downs.

A motion was made that branch 132 donate \$5,000.00 to the Disaster Relief Fund. (Passed). A motion to print New Member list and minutes in the Metro Letter Carrier. (passed). Financial reports will be printed also.



#### **New Meeting Requirements for 2021**

The Executive Board has agreed to new guidelines for paying stewards in 2021 for attendance at branch meetings and steward training. These guidelines also apply to meeting attendance requirements for delegates to the state convention in July 2021. The new guidelines are necessary because the COVID-19 pandemic has forced the branch to cease holding meetings and training at the union hall. Those activities are now held electronically, via ZOOM teleconferencing, and these guidelines are designed to work with the new procedure. Stewards and members should be aware of the following guidelines:

- \* The steward must attend the branch meeting and/or steward training via ZOOM teleconferencing to be eligible for payment. Convention delegates must attend the branch meeting via ZOOM teleconferencing to receive credit for the meeting in order to be a delegate and share in the allocated funds for the convention.
- \* ZOOM teleconferences are by invitation only. In order to receive an invitation, any member or steward should contact the union hall and provide their email address or phone number. The invitation to attend the teleconference will be issued by the branch president. The invitation will be posted on the branch Facebook pages and issued via text message or email.
- \* Everyone must log in with an identifiable tag, such as their name or a known phone number, if they do not want to turn their video on. Tags such as "TopNotchSteward", while accurate, do not serve this purpose. The phone number must be known to the branch president. The identity of each attendee will be verified by a branch officer, and any attendees who cannot be identified will be removed from the call. This also ensures that non-members and management personnel are not on the call.
- \* Stewards who are identified as present for the ZOOM teleconferencing call will be compensated in accordance with the by-laws, and counted as present for that meeting. Members who are identified as present for the ZOOM teleconferencing call will be counted as present for purposes of fulfilling the attendance requirement for the state convention.

While a vaccine is on the horizon, for the time being, no one knows when meetings will once again be held at the union hall. Teleconferencing will help keep us all safe, while also keeping everyone informed and educated, and allowing the branch to conduct its business. If you have any questions or concerns about these guidelines, please call the union hall for more guidance.


## POSTAL LOGOS THROUGH THE YEARS


The Postal Service logo is a well-known American symbol, but it hasn't always looked the way it does today. Here's how the postal insignia has evolved over time.

- 1. Mercury. In 1782, then-Postmaster General Ebenezer Hazard used an image of Mercury, the winged-messenger of the Roman gods, in his official postal seal.
- **2. Post rider.** Seeking a modern representation of the mail in motion, an image of a horse carrying a rider and a mailbag was chosen in 1837 for the Post Office Department seal.
- **3.** The eagle. When the 1970 Postal Reorganization Act transformed the Post Office Department into USPS, officials unveiled a new seal created by the firm of famed industrial designer Raymond Loewy with an eagle poised for flight.
- **4. The current logo.** In 1993, USPS adopted its current logo, which features a "sonic" blue eagle looking forward to symbolize the organization's future.
