NALC THAT'S MY UNION

If COVID-19 has taught us anything, it has taught us the importance of having a job! The unemployment rate rose to a record high of 14.7% in April 2020, leaving so many millions of people without a job. Businesses were closing, but the fear of unemployment was not a concern for letter carriers. Letter carriers, thanks to the negotiation skills of our

national officers now and in the past, have a no-layoff protection clause for carriers in the regular work force who have completed six years of continuous service. The annual base pay of a letter carrier ranges from \$20/hour to \$33.20/hour. When factoring in overtime, that hourly wage increases to \$30/hour to \$49.80/hour. If you work any penalty overtime, you will be earning from \$40/hour to \$66.40/hour. Any letter carrier can make as much money as they want if he/she is willing and able to work the hours. And let us not forget about the many benefits that come with the job: sick leave, annual leave, holidays, and so much more. Yet there are so many carriers who take the job of a letter carrier for granted.

Yes, I know that the work is not all easy, and yes, I know that some carriers work in unfavorable environments. However, if we all kept our minds on the value of the job, and what it adds to the lives of our families and what our life would be like if we did not work for the Postal Service, we would gain a deep appreciation for the job and for the communities we serve. I said all of this to make this point: it is time for us to stop getting

into shouting debates with postal management when we do not agree with their instructions or when their instructions violate the National Agreement. The job of policing the contract is the responsibility of the union steward.

It is a wonderful thing to know your rights. By knowing your rights, you will always be a step ahead of management. But knowing your rights and trying to enforce your rights by telling management what they can or cannot do, or what you are going to do or not going to do, will lead to discipline. This is referred to as insubordination. While there may have been some instances in the past where the union was successful in getting matters of insubordination settled favorably, that does not mean that we will always be successful. Getting discipline rescinded should in no way bolster anyone into believing that they can do or say whatever they want to in the work environment.

First, everyone must know that there is the "iron rule" stating that an employee must "obey now and grieve later." Second, there is a narrow exception to that rule which permits an employee to disobey an order when he or she has a reasonable or good-faith belief that to obey that order would cause imminent danger to life or limb.

This rule has been incorporated into the JCAM by the national parties because they were aware that there will be times when postal management would violate the National Agreement when giving instructions to letter carriers. Both the Postal Service and the NALC understood that when this occurred, the employee would be bound by the iron rule to obey those instructions; however, that same iron rule also gave that employee the right to file a grievance. Instead of taking matters into your own hands by engaging in verbal disputes with management, use your right to file a grievance and let the process work for you. Ask yourself if it is worth staying at home with no pay before you act. Let your union work for you!

Overtime Desired list should be completed.


Also gave an update on the COVID situation.



NATIONAL ASSOCIATION OF LETTER CARRIERS BRANCH 132 SCHOLARSHIP

- 1. Lone Star Branch 132 of the National Association of Letter Carriers will award up to five \$1,000 Scholarships a year to applicants who are selected by the Scholarship Committee. The winners must meet all eligibility requirements as determined by the Branch and described below.
- 2. The Scholarship Committee will be formed of four volunteers selected from Branch 132 and Auxiliary 28, and a fifth member will be selected from the local Educational Community. These five volunteers will be appointed each year by the Branch President.
- 3. Eligibility Requirements:
 - A. Applicant must be a high school senior at the time of application.
 - B. Applicant must be accepted to an accredited college or university and be willing to provide documentation of acceptance.
 - C. Applicant must submit copy of high school transcript and SAT or ACT test scores at the time of application. Additional personal information, such as community activities, teacher recommendations, or special achievements, is welcome, but not required.
 - D. Applicant must be a son or daughter or grandson or granddaughter of an active, retired or deceased City Letter Carrier who is a member of NALC Branch 132. Branch member must be a member in good standing for at least one year. Children of deceased members are eligible provided the widow/ widower had not remarried. Legally adopted or verifiable dependents (income tax records, divorce records, etc.) are also eligible.
 - E. Relatives of members of the Scholarship Committee are ineligible to receive a Branch 132 Scholarship during the year that the family member serves on the Committee.
 - F. Applicant must enroll as a full-time student at an accredited college or university.
 - G. Scholarships are non-renewable and will only be given for the first year of enrollment.
 - H. If unusual conditions require a postponement of schooling, the recipient must state reason(s) in writing to the Scholarship Committee and request that the Scholarship be held in abeyance. Request(s) will be received by the Committee and a decision

rendered.

- 4. Checks for the NALC Branch 132 Scholarship will be written to the college/university and will be applied toward tuition, fees, books, or room and board.
- 5. If the NALC Branch Member is suspended

by the Union, acted as a 204B within the previous 24 months, or enters supervision, the Scholarship will be cancelled.

6. Applications will be printed in the Branch Newsletter and will also be available through the Branch office. Winners **will be** announced in July.
