Where Would We Be Without A Union?

Have you ever asked yourself this question? Over my career, I have pondered this question many times. Those were the times when I found myself faced with discipline, times when I found myself fighting to obtain the contractual rights granted by the National Agreement, and times when I was forced to defend violations of the Postal Service's rules

and regulations. Those were the times that I told myself, that without a doubt, I could not work for any organization that was not represented by a union.

The need and the desire to work for an organization represented by a union began to manifest in my mind as a child. I grew up surrounded by union leaders. My father and my uncle were the President and Vice-President of the Laborers' International Union of North America Local #648. I watched the work they performed finding jobs and fighting for the rights of laborers in the Dallas area. I witnessed the satisfaction that they both gained from helping others. That same feeling transferred over into my life at an early age. So, the thought of being without a union frightens me.

During the period of January 11, 2021 to March 1, 2021, eligible members of NALC cast their mail-in ballots for the ratification of the 2019-2023 National Agreement. Voting members, which includes each active member receiving this newsletter, had an opportunity to select "accept" or "reject" for the

agreement. Ballots were mailed out to the 1,738 active eligible letter carriers in Branch 132. Five-hundred and six (506) members voted to accept the proposed National Agreement and thirteen (13) voted to reject the agreement. Two-thirds of the eligible members for Branch 132 did not exercise their right to vote on a matter that affects each and every one of them in their daily lives. This lack of voter participation alarms me!

If there were no unions, chances are that salary increases would no longer be universal. There would be no paid overtime. Promotions would be based on who management favored. The ability to bid on what work you prefer would be removed. The right to contest the actions of management would be a thing of the past. How many of you would continue to work at the United States Postal Service if you could no longer file a grievance when management violated your rights?

Do not take our Union for granted. Branch 132 has filed more grievances as of today than it filed for the entire 2020 year. Just a look at the number of grievances alone proves that our union is busy at work. It clearly demonstrates that a union is necessary and essential. I am proud of the skills and the hard work of our Union leaders who diligently perform the duties of union representation for the branch. That is the secret to our success: the men and women who unselfishly devote their time and efforts towards making NALC Branch 132 strong. These are the officers, the stewards, the Formal As, the DRT members, and the arbitration advocates. That is the source of our branch's strength!

Take a moment to ask yourself how you would feel if tomorrow you reported for work and found out there is no longer a union? Would you quit or would you tough it out? Relish the privileges that you have as a member of one of the biggest and strongest unions in existence. Take a vested interest and a proactive step in what is going on in your postal career while you still have a union. Remember that you are the UNION!

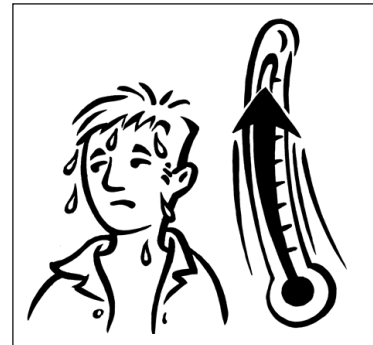

"I Was About to Pass Out"

I regularly hear this phrase from carriers who are sharing their horror stories about their experiences with the heat: "I was about to pass out." And it always aggravates me. Because if you are about to pass out, then you have waited too long to take measures to protect yourself from the heat.

If you are about to pass out, what are your options? You can't drive anywhere, because you might pass out and run off the road. You might be able to call someone, but you also might pass out before you can tell them what is wrong. You can try to walk to an air-conditioned shelter, but what if you pass out while you are walking there? And too often we hear of carriers, discovered by customers, who are passed out in driveways, because that carrier was about to pass out from the heat, but just kept going.



Before you get to the point where you are about to pass out, stop carrying mail. Yes, your supervisor might throw a hissy fit if you get back late, but that is not your problem. Your responsibility is to make sure you take care of yourself and do not succumb to the heat. Listen to your body so you can tell when the heat is starting to affect you. And when you feel that you are getting overheated, don't push yourself to the point that you are about to pass out. Stop when you first feel the effects of the heat, and go to an air-conditioned place. If you have an air-conditioned truck, sit in the truck with the A/C on (make sure you stay in the driver's seat while it is running). Drink some cool water. Relax. Take some deep breaths. You know what cools you off and what is best for you. And once you have cooled off, try again to safely carry some mail.

Don't rely on your supervisor to take care of you. If you feel you are in danger from the heat, call 911. If you need to tell your supervisor that you will return late, try texting them on the scanner to reduce the chances of a negative interaction with them. If you have to call them, cool off and relax in an air-conditioned place before you call them, and stay there while you call them.

If resting in an air-conditioned place doesn't help, then you may need to go home or go back to the station. If you do, file a report of an on-the-job injury. This can be done online at "ecompany.dol.gov", or you can get the form from your supervisor. Also fill out the Heat Injury Report that is in this newsletter, and you can email that to peralta@nalc.org or give it to your steward or branch officer.

It's a cliché, but it's true: You are your most important delivery. Delivering mail in the heat is challenging, but it should not be life-threatening. Do what you need to do to protect yourself, and never push yourself to the point that you are about to pass out.

MEETINGS RESUME AT THE UNION HALL

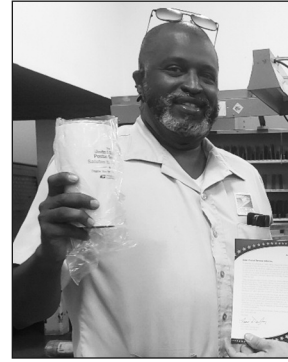
