FROM THE PRESIDENT'S DESK

KIMETRA LEWIS



I started out the new year in my last article declaring 2022 to be the year we stand up and stand out. I stated to make this happen, we need to know our jobs, know what is expected of us, and perform to the best of our ability. One area of concern throughout the branch is the increasing attendance issues. Attendance issues are prevalent in nearly every office within the branch. It is understandable that employees will at times become ill and/or have emergency situations that prevent

them from reporting for duty. That understanding was taken into consideration by the Postal Service and is expressed in the regulations outlined in the Employee and Labor Relations Manual (ELM).

All employees of the Postal Service are required to be regular in attendance. Sick leave is an earned benefit. The purpose of sick leave is to ensure employees against loss of pay if they are incapacitated for the performance of duties because of illness, injury, pregnancy and confinement, and medical (including dental or optical) examination or treatment. Except for unexpected illnesses, sick leave must be requested on a PS Form 3971 (Request for or Notification of Absence) and approved in advance by management. Annual leave is also an earned benefit. Annual leave is provided to employees for rest, for recreation, and for personal and emergency purposes. Except for unexpected emergencies, annual leave must be requested on a PS Form 3971 and approved in advance by management. Any request for annual and sick leave not requested and approved in advance will be considered as unscheduled leave. A tardy can also be considered as unscheduled leave. Any use of unscheduled leave can become the subject of disciplinary action.

Section 665.41 of the ELM states, "Employees are required to be regular in attendance. Failure to be regular in attendance may result in disciplinary action, including removal from the Postal Service." A large percentage of carriers believe that their absence for sick leave is excused if they provide medical documentation; however, that is far from the truth. Section 511.41 of the ELM defines unscheduled absences as "any absences from work that are <u>not</u> requested and approved in advance." The Union has and will continue to fight diligently for those carriers who are issued discipline for their attendance records. However, while we may have been successful in getting some discipline overturn, that does not change the requirement to be regular in attendance and it does not mean we will be able to continue to do so. A lot of attendancerelated discipline has been overturned due to technical errors on the part of management, not because the discipline was not warranted.

It is your responsibility to be regular in attendance. It is also your responsibility to submit a PS Form 3971 upon your return to work. Section 513.332 of the ELM states in part, "*PS Form 3971, Request for or Notification of Absence, will be provided to the employee upon his or her return to duty.*" Do not allow management to fill out a PS Form 3971 for you. Request the form upon your return to duty and fill it out yourself. This has been an ongoing issue that creates a problem when the Union attempts to defend a carrier's attendance record. If you have a chronic medical condition that causes you to be absent from work on a continual basis, you need to request FMLA (Family Medical Leave Act) to protect your absence from discipline. Management is required once they are made aware of an employee having a chronic medical condition to offer FMLA; but they cannot do so if they are not made aware of your medical condition.

Putting our careers in a positive direction begins with reporting to work as required. Letter carriers are the backbone of the Postal Service. It cannot exist without us; therefore, it is important that we take our careers seriously by reporting to work as schedule. Let us stand up and stand out!





LEGISLATIVE UPDATE

The Postal Service Reform Act **HR 3076** passed the House of Representatives in a vote of 342-92. President Fredric Rolando called the passage 'a huge victory for the American people, who rely on the Postal Service for affordable and highquality universal service."

This was a bipartisan bill to strengthen the Postal Service, with provisions that eliminate the mandate on the Postal Service prefunding retiree health care benefits and six-day delivery. It also includes provisions to reduce postal health care by increasing participation in Medicare on a prospective basis. Please take a few minutes to call your Congressional Representative and **thank** them for taking the courage to vote for this bill.

EXECUTIVE VICE PRESIDENT'S REPORT

Our branch is one of the largest in the country, with about 75 offices that we represent throughout north and east Texas. In recent years, it has become more challenging to ensure that all our members are properly represented, where we have no steward, no matter how far away, or how small their station.

The responsibility of ensuring that all our members are represented, belongs to the full and part-time officers of this branch, namely the President, the Executive Vice President and the Vice President. Each one of us have designated offices that we represent, where there is no steward. There are also occasions when the Branch President will designate outside stewards to represent letter carriers in stations, other than their own. The grievance procedure can be very challenging to facilitate, when we are not on site. The following is an example of my typical day.

I usually start my day at a station before I come to the office. I always do at least one of the following. (1) Request or pick up documents. (2) Meet with letter carriers that want to file grievances. (3) Meet with the immediate supervisor at Informal A. (4) Appeal grievance to Formal A. (5) Meet with the postmaster or designee at Formal A. In addition to these in person contacts, I also have to schedule all these meetings in advance via e-mail, texts, and phone calls, sometimes for multiple stations on the same day. What I just described, also applies to the other two officers that I mentioned.

I believe it is important that the membership know what their officers are doing on behalf of the membership daily. I know I can speak for the other two officers, when I say that we never run out of things to do, which of course includes our other duties once we get back to the office.

This branch will always do whatever it takes to represent our membership.

NATIONAL ASSOCIATION OF LETTER CARRIERS BRANCH 132 SCHOLARSHIP

1. Lone Star Branch 132 of the National Association of Letter Carriers will award up to five \$1,000 Scholarships a year to applicants who are selected by the Scholarship Committee. The winners must meet all eligibility requirements as determined by the Branch and described below.

2. The Scholarship Committee will be formed of four volunteers selected from Branch 132 and Auxiliary 28, and a fifth member will be selected from the local Educational Community. These five volunteers will be appointed each year by the Branch President.

3. Eligibility Requirements:

A. Applicant must be a high school senior at the time of application.

B. Applicant must be accepted to an accredited college or university and be willing to provide documentation of acceptance.

C. Applicant must submit copy of high school transcript and SAT or ACT test scores at the time of application. Additional personal information, such as community activities, teacher recommendations, or special achievements, is welcome, but not required.

D. Applicant must be a son or daughter or grandson or granddaughter of an active, retired or deceased City Letter Carrier who is a member of NALC Branch 132. Branch member must be a member in good standing for at least one year. Children of deceased members are eligible provided the widow/ widower had not remarried. Legally adopted or verifiable dependents (income tax records, divorce records, etc.) are also eligible.

E. Relatives of members of the Scholarship Committee are ineligible to receive a Branch 132 Scholarship during the year that the family member serves on the Committee.

F. Applicant must enroll as a full-time student at an accredited college or university.

G. Scholarships are non-renewable and will only be given for the first year of enrollment.

H. If unusual conditions require a postponement of schooling, the recipient must state reason(s) in writing to the Scholarship Committee and request that the Scholarship be held in abeyance. Request(s) will be received by the Committee and a decision

rendered.

4. Checks for the NALC Branch 132 Scholarship will be written to the college/ university and will be applied toward tuition, fees, books, or room and board.

5. If the NALC Branch Member is suspended

by the Union, acted as a 204B within the previous 24 months, or enters supervision, the Scholarship will be cancelled.

6. Applications will be printed in the Branch Newsletter and will also be available through the Branch office. Winners **will be** announced in July.
