FROM THE PRESIDENT'S DESK

In the month of April, the Texas delegation of legislative liaisons visited the State of Washington on a legislative trip. There we visited with the congressmen and women who represent the State of Texas to gain their support for the legislative bills that effect the Postal Service and its workers, specifically us. We gathered together as a group to strategize our plan of action. We were well versed on the facts and were prepared to engage in

intellectual conversation on the issues of our concerns. Meetings were scheduled around the clock; ahead of our visits. If we got no scheduled visit, we still showed up. No Texas member of Congress was missed, whether Democrat or Republican.

We introduced ourselves by explaining who letter carriers are. Hard workers who worked during rain, sleet, snow or Covid. Over thirty (30) percent are veterans, who worked diligently to protect this country and who are now working just as hard to protect the mail entrusted in their care. We are a diverse group of people, consisting of men and women of all races and creed. We are community leaders who provide charity assistance to those who are in need of food with our Annual Stamp Out Hunger Food Drive and we are a long-time sponsor to the Muscular Dystrophy Association. We are the eyes and ears of the public each and every day.

In our visit, we discussed our need for Congress to support the Protect Our Letter Carriers Act (H. R. 1065/S. 463) This bill will provide funding to the Postal Service that would be used to install high-security collection boxes and cover the cost to

replace items carried by letter carriers with more secure electronic versions; thus, reducing the numbers of robberies. This bill would require the attorney general to promptly appoint an assistant U.S. attorney in each judicial district to prioritize any case that involves an assault or crime against a letter carrier. This would strengthen the sentencing guidelines for these crimes, ensuring that they are treated in the same manner as assaults on federal law enforcement officers.

We also advocated for the support of the Federal Retirement Fairness Act (H.R. 1522). The passing of this bill would benefit more than 65 percent of the current letter carriers by allowing them the opportunity to purchase retirement credit for the time they spent as non-career employees; thereby, providing greater retirement security. Last but not least, we expressed our desire for Congress to oppose postal privatization (H.Res. 70/S.Res. 147). The Postal Service is the core of the United States mailing industry. We are the last mile delivery to every business and residential customer in the country seven days a week. To privatize the Postal Service would be a detriment to the millions of Americans who rely upon our service; especially those in rural areas because their mail service would suffer as their delivery of mail would not be profitable for a private investor.

We need the support of Congress. To get this accomplished cost money. This is why it is so important that each letter carrier contributes to the Letter Carrier Political Fund. We all know, money speaks in the political world. Money gets results. If you are contributing, thank you. If you are not contributing start. This cannot be expressed enough. Our jobs are under attack. The future of the Postal Service is wavering. Let's not get caught slipping. Do your part.



National Association Of Letter Carriers Branch 132 Scholarship

- 1. Lone Star Branch 132 of the National Association of Letter Carriers will award up to five \$1,000 Scholarships a year to applicants who are selected by the Scholarship Committee. The winners must meet all eligibility requirements as determined by the Branch and described below.
- 2. The Scholarship Committee will be formed of four volunteers selected from Branch 132 and Auxiliary 28, and a fifth member will be selected from the local Educational Community. These five volunteers will be appointed each year by the Branch President.
- 3. Eligibility Requirements:
 - A. Applicant must be a high school senior at the time of application.
 - B. Applicant must be accepted to an accredited college or university and be willing to provide documentation of acceptance.
 - C. Applicant must submit copy of high school transcript and SAT or ACT test scores at the time of application. Additional personal information, such as community activities, teacher recommendations, or special achievements, is welcome, but not required.
 - D. Applicant must be a son or daughter or grandson or granddaughter of an active, retired or deceased City Letter Carrier who is a member of NALC Branch 132. Branch member must be a member in good standing for at least one year. Children of deceased members are eligible provided the widow/widower had not remarried. Legally adopted or verifiable dependents (income tax records, divorce records, etc.) are also eligible.
 - E. Relatives of members of the Scholarship Committee are ineligible to receive a Branch 132 Scholarship during the year that the family member serves on the Committee.
 - F. Applicant must enroll as a full-time student at an accredited college or university.
 - G. Scholarships are non-renewable and will only be given for the first year of enrollment.
 - H. If unusual conditions require a postponement of schooling, the recipient must state reason(s) in writing to the Scholarship Committee and request that the Scholarship be held in abeyance. Request(s) will be received by the Committee and a decision

rendered.

- 4. Checks for the NALC Branch 132 Scholarship will be written to the college/university and will be applied toward tuition, fees, books, or room and board.
- 5. If the NALC Branch Member is suspended

by the Union, acted as a 204B within the previous 24 months, or enters supervision, the Scholarship will be cancelled.

6. Applications will be printed in the Branch Newsletter and will also be available through the Branch office. Winners **will be** announced in July.
